#### **Objectives:**

With the support of the Ministry of Education, Culture, Sports, Science and Technology (MEXT) of the Japanese Government, this annual "International Anti-Doping Seminar in Asia" is hosted by the Japan Anti-Doping Agency (JADA) in partnership with the World Anti-Doping Agency (WADA).

It aims to share the expertise and knowledge and increase the competence for the delivery of anti-doping activity in Asia. This year's theme is on the effective implementation and application of the 2015 World Anti-Doping Code (Code) and the International Standards (ISs). There will be the roundtable group discussions and all the participants would be expected to participate with their high awareness and motivation. It is aimed to inform the Asian colleagues to be prepared for their implementation of the 2015 Code and ISs and deliver the anti-doping programme effectively. We hope to extend our coordinated approach to strengthen our anti-doping programme.

- The NADOs/RADOs are prepared to implement the revised Code and ISs
- The NADOs/RADOs are well-informed on the revised points and their roles and responsibilities and can communicate and inform the 2015 Code and ISs to their stakeholders
